**DEFENDANTS' OPPOSITION TO PLAINTIFF'S MOTION FOR
CRIMINAL COMPLAINT AUTHORIZATION (DE 19)**

Plaintiff, _____, has filed a motion requesting authorization to file a criminal complaint against Defendants' attorney for filing a fraudulent amended return of service (DE 19). The Defendants oppose the motion. In opposition, the Defendants show:

1. Plaintiff filed a return of service, signed by a process service, claiming service on Defendant, Treasury Secretary Jacob Joseph Lew (DE 8) by leaving a copy of the complaint and process with a mail clerk at the Treasury Department. The original return of service did not state whether service was against Lew in his official or individual capacity.¹ The Defendants' attorney contacted the process service to clarify whether the mail clerk had accepted service for Secretary Lew in his individual capacity. The process server's amended affidavit make clear that the mail room clerk, who accepted service for Secretary Lew, was authorized to accept service for Secretary Lew in his official capacity but not in his individual capacity. The amended affidavit of service was attached as Government Exhibit 1, Motion to
